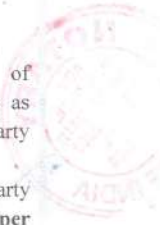

Now it is agreed between the parties as follows:

1. According to criteria the First Party will continue to impart comprehensive basic sciences training in the specialty/subjects like Anatomy and Physiology as per the curriculum by deputing concerned teachers to the Second Party hospital according to the time table mutually agreed.
2. The first Party will arrange appropriate number of demonstrations/practicals/group-discussion/ in Basic Sciences as related to the specialty concerned with help of the First Party teaching faculty.
3. Payment on account of this training programme, the First Party will be paid by the Second Party an honorarium of Rs. 1500/- per demonstration or practical.
4. The period of the Memorandum of Understanding (MoU) will be initially for a period of One year from 2023-24 Academic Year with renewal at start of new Academic Year from August each year.
5. This agreement/MoU may be revised from time to time by mutual understanding between the parties duly recorded and signed on behalf of both the parties.




6. This agreement/MOU may be terminated by either party by giving three months prior notice during which time all the agreed upon conditions shall be deemed to be enforce.
