03) Proposed Modes of Collaboration

Collaboration with **Pathak Viddhashram Of Pathak Trust ,Tal- Miraj, Dist., Sangli**, for research activity, practical demonstration for providing interdisciplinary knowledge. A specific plan will be worked out by institutes depending upon availability of resources.

03) Terms and conditions

Both institutes agree to help the students for their study work as per the terms and conditions of institutions. This MOU may be amended, renewed and terminated by mutual written agreement of the institutions at any time. Either Institute shall have the right to terminate the MOU upon 60 days prior written notice to the other institute.

05) Confidentiality

Institutes agree to hold in confidence all information data designed by the institutes as being confidential which obtain from either institute or created during the performance and will not disclose to same to any third party without written consent of the other institute.



06) Duration

The period of the Memorandum of Understanding will be initially for a period of five years beginning from the academic year 2023-2024 and may be revised from time to time by mutual understanding between the parties duly recorded and signed on behalf of both the parties.

07) Coordinators

Both institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.

08) Intellectual property Rights

The intellectual property right (IPR) that arises as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes.

09) Signed in Duplicate

This MOU is executed in duplicate with each copy an official version and having equal legal validity. By signing below, the institutes, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as on the day and year first above written.
